SUBJECT: REDESIGNATION OF TRUSTEES FOR THE SFRC PENSION TRUST AND 401K PLAN

Recent Staff departures require that new trustees be appointed to the existing Council employee plans. To recap, the agency has two funds:

- 1. SFRPC Pension Trust This fund covers only two of the original SFRPC employees as they pre-dated Florida Retirement System (FR) participation. All other Full-Time Employees are covered under the State's FRS Plan.
- 2. SFRPC Employees' Savings Plan (401K) All Full-Time Regular Employees are eligible.

The attached resolutions were prepared by the Council's Pension Advisor and approved by General Counsel for the purpose of removing former Staff as Plan Trustees and appointment of replacements.
