1. Welcome and Pledge of Allegiance

The meeting was called to order by the Chair at 10:02 am.

2. Introductions

3. Previous Meeting Summary

The minutes from the May 29, 2019 meeting were moved by Axel Rodriguez, seconded by Niel Batista and approved unanimously.

4. Membership Changes (Manny Cela)

Coordinator Manny Cela briefed the members on the two pending membership nominations from Chief Garcia and Capt. Russo, both with the Hollywood Fire Department. The item was moved by Troy Johnson, seconded by Dave Dungan and approved unanimously.

5. Subcommittee Reports

<u>Training Subcommittee</u> (Manny Cela)

Coordinator Manny Cela reported on this year's training activities. For the very first time, all training funds were spent by July. In total, 445 students have been offered nearly 10,000 class hours this year.

Mr. Cela mentioned outreach from Monroe County FR regarding a Hybrid HM160 class as well as the Bureau of Prisons for awareness training. Additional free training can be found through SERT TRAC and PHMSA. We will review HazMatIQ offerings (last time it was \$6,000 per single class of 30 students).



Planning Subcommittee (Manny Cela)

Although no Planning Project was selected last year, we are likely to recommend "Plan an Exercise" at the November meeting for next year in order to support the new annual exercise.

Exercise Subcommittee (Manny Cela)

There was much discussion on the CSX Rail exercise. Prior to the meeting, a 20-minute video of the event was shown on the big screens. Photos of the exercise played in the background during the meeting. Coordinator Manny Cela, Chair Ray McDonald and many other members present at the exercise provided their opinions, comments and take-aways. Many of these may be incorporated into the AAR.

6. 2019 HazMat Emergency Response Plan Update (Manny Cela)

The Updated 2019 Plan is available for download from www.soflalepc.org. The 2020 update process will begin after the new year.

7. SERC Thomas Yatabe Award and Certificates of Appreciation

Chair McDonald announced the nominees for the Yatabe Award (SERC TTF Rep Lt. Maikel Garcia/MFR) and Certificates of Appreciation (Peter Schecter/JetBlue and Dave Dungan/Memorial Healthcare). The item was moved by Niel Batista, seconded and approved unanimously.

8. SoFlaLEPC Coordinator Report (Manny Cela)

Mr. Cela described changes in the new LEPC Contract, including the exercise requirements. Also discussed was the hiring by FDEM of a consultant to work with the Florida Fire College to do team assessments of all hazmat teams. Additionally, FDEM has its attorney looking into conflict of interest and financial disclosure form matters for LEPC members.

Mr. Cela also mentioned his two recent presentations to the SFRPC and USCG.

9. Member Comments

Vice Chair Chief Shaw discussed his appointment to the International Association of Fire Chiefs and the first meeting he attended. Molly Merrifield from the National Weather Service introduced herself and offered to assist in future exercises. Martin Mueller/Gallagher Marine introduced himself. Lisa Maxwell/FDEP distributed stickers with important phone numbers. Freda Vaughn/FDOH spoke about the HepA epidemic and participation on Biowatch for the Super Bowl, which brought on an extended discussion on security and preparations for the game, including from Lt. Al Tonanez/MDFR.
