SUBJECT: ECONOMIC DEVELOPMENT DISTRICT

The Council has served as the U.S. Department of Commerce Economic Development Administration's designated Economic Development District for South Florida since 1994. The Economic Development District service area is Monroe, Miami-Dade, and Broward counties where the Council helps lead a locally-based, regionally driven, economic development process. EDA has invited Economic Development Districts to apply for supplemental awards to help respond to the unusual and compelling urgency of the coronavirus pandemic. EDA has determined that the Economic Development Districts, by virtue of the longstanding and substantial investment in building capacity to respond to economic shocks and ongoing partnership with EDA, are best suited to support the CARES Act Recovery Assistance initiative.

The Council has been invited to apply for a supplemental financial assistance award of up to \$400,000 to undertake one or more preapproved activities: (1) development of an economic recovery and resilience plan; (2) the deployment of disaster recovery coordinator(s); (3) the provision of technical assistance; and (4) the funding of appropriate technology and staff support for these pandemic-response activities. The period of performance is 24 months. EDA is funding the supplemental award at a 100 percent federal grant rate.

Additionally, EDA has invited the Council to apply for a single supplemental financial assistance award with two components: (1) up to \$5,380,000 to capitalize a new revolving loan (RLF) fund to alleviate sudden and severe economic dislocation caused by the pandemic and (2) up to an additional ten percent of that amount to defray administrative costs necessary to establish the new RLF and facilitate rapid and prudent lending to the pandemic. EDA is funding the supplemental RLF at a 100 percent federal grant rate.

Council staff is working on both applications.

SFRPC Small Business Revolving Loan Fund

The South Florida Regional Planning Council is expected to receive \$5,380,000 in supplemental financial assistance to capitalize a new revolving loan (RLF) fund to alleviate sudden and severe economic dislocation caused by the coronavirus (COVID-19) pandemic. U.S. EDA FY 2020 Disaster Supplemental

- This <u>Notice of Funding Opportunity</u> covers \$1.5 billion in EDA funding nationally, of which \$248 million is for the eight-state Atlanta Region. Florida is competing with Alabama, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, and Tennessee.
- For this funding, the entire nation has been recognized as impacted, special need, and eligible for funding. There is no need to spend time on articulating and documenting the

normal economic distress criteria that is normally required for Public Works or Economic Adjustment investments (unemployment rate, per capita income, special need).

- For the CARES Act Recovery Assistance, one needs to look at the 5-page Addendum (5 pages) and the original Public Works and Economic Adjustment Assistance Programs NOFO (45 pages). The attached EDA handout provides easy reference to EDA's five (5) investment priorities. The website is important for updates and other information: https://www.grants.gov/web/grants/view-opportunity.html?oppld=321695.
- Eligibility: Proposals must clearly identify how the proposed project would "prevent, prepare for, and respond to coronavirus" or respond to "economic injury as a result of coronavirus." The priority that every application needs to advance first and foremost is Priority # 1: Recovery & Resiliency. Every project must be consistent with the South Florida CEDS plan and advance investment priorities. The investment priorities are: Recovery & Resiliency, Critical Infrastructure, Workforce Development & Manufacturing, Exports & FDI, and Opportunity Zones. Eligible applicants are found on page 2 of the Addendum.
- **Cost sharing:** EDA generally expects to fund at least 80% and up to 100% of eligible project costs. 20% match is preferred.
- Proposals should be submitted as soon as possible as it is expected that funds will be allocated quickly.
- Projects must be completed by December 2022.

U.S. EPA Grant Funding – Environmental Justice Communities Impacted by COVID-19

EPA is working to improve the environment and public health conditions of low-income and minority communities through our daily efforts to ensure all Americans have clean air, safe water, and access to information to make decisions to protect personal and public health. As part of these efforts, EPA has re-opened the State Environmental Justice Cooperative Agreement Program (SEJCA) and expanded its availability to include states, local governments, tribes and territories.

EPA is giving a special consideration to those applications aimed at addressing the impacts of the COVID-19 pandemic on urban and rural low income and minority communities.

EPA anticipates making five awards in amounts of up to \$200,000 per award for a two-year project period. EPA encourages applicants to develop innovative plans and processes to conduct effective outreach to underserved communities in the midst of social-distancing and local stay-at-home orders, especially in places where internet access may not be readily available to all residents.

The opportunity closes on June 30, 2020 at 11:59 PM (ET).

Rebuild Florida's Mitigation Programs

CDBG-MIT

The U.S. Department of Housing and Urban Development (HUD) announced that \$633 million in first-of-its-kind funding would be available to the state of Florida for disaster mitigation projects in <u>areas impacted</u> by presidentially declared disasters in 2016 (Hurricanes Matthew and Hermine) and 2017 (Hurricane Irma). These funds are available through HUD's newly created Community Development Block Grant - Mitigation (CDBG-MIT) and will be used to fund disaster mitigation programs to better protect Florida from future disasters:

Rebuild Florida Critical Facility Hardening Program (\$75,000,000 - Launched April 15, 2020)

This program assists units of general local government and state agencies to harden critical buildings that serve a public safety purpose. A <u>Webinar</u> to provide information about the program was held on April 22nd.

Rebuild Florida General Planning Support Program (\$20,000,000 - Launched May 15, 2020)

Provide funding opportunities to units of general local government (UGLG), educational institutions, state agencies, and non-profits for the purpose of developing and updating state, regional and local plans. A Webinar providing an overview of the program will be held on May 21, 2020 at 2 p.m. EST. Register here.
