SUBJECT: AUDIT FIRM SELECTION CONFIRMATION

Council staff issued a Request for Proposal (RFP) for Audit Services on July 25, 2016. The RFP was noticed on the Council website, FAW, and Miami Herald. The RFP response period closed on August 12, 2016.

While several inquiries were received, the single respondent to the RFP was the firm S. Davis & Associates, P.A. This firm has worked successfully with the Council on two previous occasions. Upon consultation with Councilmember Ross, the Council's designated representative on the Audit Selection Committee; it was decided to proceed with the firm interview on August 29th instead of opting for an immediate reissuing of the RFP.

After reviewing and evaluating the proposal received, the Audit Selection Committee interviewed the S. Davis & Associates, P.A. firm, and those partners and associates who would perform the audit work. The interview was satisfactory. Staff has confirmed that the respondent is not on the State of Florida's list of convicted or suspended vendors, and inquiries with the Florida Department of Business and Professional Regulation have determined that this firm has had no probable cause or action found.

Information about the S. Davis and Associates, P.A. firm and their clients, past and present, is attached for your review and information. The Audit Selection Committee recommends that the Council enter into a 5-year contract for audit services with S. Davis & Associates, P.A.
