Mr. Goren summarized the lease information discussed at the special meeting in December 2017.

The discussion today is regarding the termination of the lease with the current landlord and the authorization to move forward with a Kimco Realty Corporation lease for a temporary suite and a suite to be built out at the Oakwood Business Center at 1 Oakwood Boulevard, Hollywood, Florida. Ms. Cosio Carballo explained the time line of the move to the temporary suite and the build out of the permanent suite. The move is scheduled for March.

There was discussion on the SFRPC moving (the logistics and timeliness), the current lease, and holdover rent.

Councilmember Goldberg introduced Brad Dinneen, Senior Associate for Stiles Realty. He is managing the proposed lease with Oakwood Business Center and has been very helpful throughout this process. Chair Caplan thanked Councilmember Goldberg and Brad for their time and involvement.

Ms. Cosio Carballo explained the future plans on moving into a temporary suite while a larger suite will be built-out accordingly, at the Oakwood Plaza location.

Councilmember Ross moved to authorize the Executive Director to provide a notice of termination to the current landlord. Councilmember Cava seconded the motion, which carried by a unanimous vote.
