#### II. Approval of Council Agenda

Councilmember Furr moved to approve the Council Agenda. Councilmember Corradino seconded the motion, which carried by a unanimous vote.

#### III. Welcome – The Honorable Sylvia Murphy, Monroe County Mayor

Chair Ross gave a brief description of Mayor Murphy's background and her employment history.

Mayor Murphy thanked Chair Ross and welcomed everyone to the Murray E. Nelson Government Center and Key Largo.

### **IV.** Guest Speakers:

The Honorable Holly Raschein, State Representative, 120<sup>th</sup> District

• 2019 State Legislative Session Preview

Chair Ross introduced State Representative Raschein. State Representative Raschein has been in office since 2012 and represents the 120<sup>th</sup> District which includes Monroe County and the southern part of Miami-Dade County. He gave details on her background, governmental interests, and state legislative committees including her appointment as the Chair of the Agriculture and Natural Resources Appropriations Subcommittee.

State Representative Raschein continues to be a strong advocate for the environment, one of Governor DeSantis's priorities. This is an issue that is important to South Florida. She explained in detail the Governors' funding for environmental spending. This includes the Everglades Restoration, water quality projects, red tide/blue-green algae research, Lake Okeechobee, and other environmental issues. Governor DeSantis has created the Office of Environmental Accountability and Transparency which will be led by a Chief Science Officer. The Chief Science Officer position will be filled through a global search. She explained the various task forces on research the Governor is initiating. As Chair of the Agriculture and Natural Resources Appropriations Subcommittee, State Representative Raschein is excited to be overseeing the funding of these programs and task forces. She highlighted HB 385, regarding Transportation and Infrastructure, and explained the legislation in detail. It was requested that the SFRPC provide suggestions/input regarding the legislation. Healthcare, infrastructure, local government preemption, Monroe County's Area of Critical State Concern, and the changes in the State's administration were other issues that were mentioned.

Information on the Office of Environmental Accountability and Transparency regarding Lake Okeechobee's discharges, as well as, other water projects prioritization and funding was described. The Office of Environmental Accountability and Transparency is housed within the Office of the Secretary of the Department of Environmental Protection. The Department of Environmental Protection (FDEP) is the lead Agency, with the South Florida Water Management District under it. There was discussion on funding and concerns for the Florida Reef Tract, outfall, water quality, Florida Forever, Everglades Restoration, Lake Okeechobee Regulation Schedule, workforce housing, and the Sadowski Fund. Ms. Cosio Carballo stated that the South Florida and Treasure Coast Regional Planning Councils are collaborating on regional issues such as those mentioned at this meeting. Laura Corry, SFWMD Representative, stated the Army Corps of Engineers is having public meetings to gather the public's comments on the regulation schedules and determination of water releases for Lake Okeechobee.

The Honorable Heather Carruthers, Monroe County Commissioner, District 3

• National Flood Insurance Program Update / Flood Mitigation Options

Chair Ross introduced Monroe County Commissioner Heather Carruthers and described her many past accomplishments.

Commissioner Carruthers presented an update on the National Flood Insurance Program (NFIP). The presentation included the history of flood coverage, global flood risk, flood risk throughout Florida,

updating of the Federal Emergency Management Agency (FEMA) maps, strategies to properly fund flood insurance nationally, affordability, etc. The need for NFIP was described. Coastal areas are the economic engine of the United States and generate 46% of national gross domestic product (GDP). NFIP is needed for the protection of homeowner's assets, property values, and the nation's economy. She explained the reauthorization of NFIP, new FEMA flood maps, and Monroe County's involvement with the coastal mapping, Coastal Zones, and the Limit of Moderate Wave Action (LiMWA) line. She underscored the importance of obtaining flood insurance before the new maps become effective and the policy changes that will occur, the relationship of house elevations and new construction to Flood Insurance Premiums, suggested changes to the NFIP, and the reason for maintaining access to affordable flood insurance. Reform ideas were noted along with the House Financial Services Committee leadership, and the Senate and House support and ideas. Commissioner Carruthers will be traveling to Washington, D.C. to meet with the House of Financial Services and the Florida Delegation to continue education on the importance of Flood Insurance.

Emily Schemper, AICP, CFM, Acting Senior Director, Planning and Environmental Resources and Juanita R. Jones, PMP, Housing Recovery Administrator, Planning and Environmental Resources

• Overview of Hurricane Irma Recovery Efforts; Affordable and Workforce Housing

Emily Schemper reminded the Councilmembers about the homes, including workforce housing, that were lost due to Hurricane Irma and the recovery efforts that are still underway. She introduced Juanita Jones, the Monroe County Housing Administrator and described her past work experience. Ms. Jones and Ms. Schemper explained the handout regarding the housing recovery initiatives, and available and possible funding programs in Monroe County, such as Community Development Block Grant (CDBG) funding, Pilot Programs, Rebuild Florida Program, Florida Housing Finance Corporation, Hazard Mitigation Grant Program – Disaster Recovery, as well as other opportunities. Discussion ensued regarding funding, land acquisitions, rebuilding/reconstructing homes, affordability, criteria, and conditions on all the Programs, in which Ms. Schemper and Ms. Jones went into detail.

V. Special Recognition – George Neugent, former Monroe County Commissioner, District 2, and the Honorable Jimmy Weekley, Key West City Commissioner, District 1

Chair Ross gave a brief summary of past Councilmembers Neugent and Weekley and presented them with a plaque of appreciation in recognition of their leadership during their service on the Board for more than 20 years. Both past Councilmembers Neugent and Weekley expressed their pleasure serving on the Council and thanked everyone, mentioning Sam Goren's dedication and friendship. Pictures were then taken of those present.
