II. Approval of SEFRPI Agenda

III. Action Items

A. Minutes of Previous Meeting

Boardmember Levine Cava moved to approve the Minutes of the Previous Meeting. Boardmember Daubert seconded the motion, which carried by a unanimous vote.

B. Financial Report

Manny Cela, of Council staff, stated there were no anomalies to report. Two financial reports were presented: Financial Report for FY Ended 9/30/18 and Financial Report for the period of October 1 – December 31, 2018.

Boardmember Geller moved to approve the Financial Report. Boardmember Daubert seconded the motion, which carried by a unanimous vote.

Executive Director Isabel Cosio Carballo gave a brief history of the Southeast Florida Regional Prosperity Institute (SEFRPI), formerly known as the Institute of Community Collaboration (ICC). In the past, the ICC's primary function was meeting facilitation and consensus building among stakeholders on community and regional issues. The Council worked with many local governments on these issues. We would like to offer these services once again. The SEFRPI is a 501 (C) 3 non-profit. This enables entities who are unable to contract with government agencies to work with the Council through the SEFRPI.

Mrs. Cosio Carballo updated the Boardmembers on the new office and Council staff.

Program Reports and Activities

Mrs. Cosio Carballo introduced Dick Ogburn, former Council staff, who is contracted to assist with demographic projects, census information, economic impact assessment, etc. Mr. Ogburn reviewed the handout regarding the "Place of Birth by Citizenship Status" from the Census Bureau's 2017 American Community Survey (ACS) for the Southeast Florida Region. He mentioned that there is a discussion about adding a question on the 2020 Census regarding citizenship. There are concerns that a citizen criteria question could discourage some residents from responding, therefore effecting the decennial head count. The handout shows that data about citizenship status is being collected through the ACS, which is based on a sample of households. The Census Bureau estimates that 45% of South Florida's residents are foreign-born and over 900,000 are not citizens. The inclusion of a citizenship question on the 2020 Census could result in an undercount of residents in Florida and other states with large immigrant populations. This could impact the distribution of Congressional Representatives among the states, along with federal funding allocations for the next decade. There was discussion on the legal proceedings to include/remove the Citizenship question. Immigration in other countries was discussed.

Mr. Ogburn reviewed the history of the Southeast Florida Economic Forecasting Partnership, formed in 1993, made up initially of the seven counties in Southeast Florida, the SFRPC and TCRPC, and the South Florida Water Management District. The purpose of the Partnership is to bring a systematic approach to economic impact analysis in the region. The Partnership acquired Policy Insight, an eight-area economic and demographic forecasting model, from Regional Economic Models, Inc. (REMI). He explained that the model is configured for each of the seven counties, plus an eighth area that is comprised of the remainder of the State. The model can produce analysis of economic policy decisions and projects in 72 economic sectors, for periods up to 2060. Members of the Partnership have used the model for fifteen years; the active partners at this time are Palm Beach and Miami-Dade County. The Partnership meets several times each year to discuss economic impact assessment, with technical support from REMI.
