

Subject: Broward County Comprehensive Plan Amendment 20-T2- Capital Improvements Element (CIE): Transmittal for Expedited State Review

Dear Mr. Eubanks:

On June 2, 2020, the Broward County Board of County Commissioners adopted Resolution 2020-311 transmitting a proposed amendment to the Broward County Comprehensive Plan's Capital Improvements Element to designated state review agencies. Accordingly, these amendments are being transmitted to your agency for expedited state review.

The Broward County Environmental Protection and Growth Management Department's Local Planning Agency held its public hearing on March 23, 2020. Complete digital copies of the amendment package include supporting data and analysis.

The proposed amendment:

- Amends Capital Improvements Element Objective CI1 and related policies CI1.11 and CI1.14 to reflect a new Broward County voter-approved Transportation Surtax, a 30-year, one percent sales surtax for local transportation projects.
- Adds new Table CI-O to the five-year schedule of capital improvements to provide for transportation sales surtax projects.
- Adds the 2020 schedules of capital improvements of the Board of County Commissioners and Broward Metropolitan Planning Organization to the Comprehensive Plan's Capital Improvements Element.

Broward County expects to adopt the proposed amendments in late August or early September 2020. The proposed amendments are not related to an area of critical state concern designated pursuant to Section 380.05, Florida Statutes.
