A message from the Chair...

On behalf of the Council and its staff, we would like to take this opportunity to thank you for your support of the Council and its regional efforts. Since 1974, the South Florida Regional Planning Council (Council) has served as the regional planning agency for Monroe, Miami-Dade, and Broward counties. It is governed by a public/private board of county and municipal elected and Gubernatorial appointed officials from three counties. The Council supports the region's elected leaders and public, private, and nonprofit stakeholders through regional, collaborative planning and the development and implementation of programs and strategies shaping a better future for South Florida.

This year the SFRPC excelled in its endeavors to help make South Florida a better place for its businesses and residents. In FY 19-20 the Council leveraged \$9.15 in additional funding for the region for every \$1 in dues contributed by the counties. A signature accomplishment was securing a new \$5.9 million CARES ACT Revolving Loan Fund program to alleviate sudden and severe economic dislocation caused by COVID in South Florida. These funds will continue to revolve in perpetuity creating a continuing source of needed business capital to grow and sustain businesses. With this and other programs, the Council continues to take new steps to promote entrepreneurial growth and raise awareness about the resources that are available to our local partners and diversify South Florida's economy. Council staff continues to provide technical assistance and implement transportation, emergency preparedness, economic development, clean fuels, data and research, and resiliency programs. We will be emphasizing our role in "Regional Planning" through the coordination and hosting of conferences and other events intended to facilitate the exchange of ideas with interested community stakeholders, including private organizations, on issues relevant to the region and its future vitality and sustainability.

We look forward to a great year ahead as we continue our work to diversify and grow South Florida's economy, strengthen communities, and increase opportunity for residents while enhancing the environment and quality of life throughout the region. MIAMI-DADE TPO TRAVEL BEHAVIOR TREND ANALYSIS

Council staff is in the initial stage of developing a Scope of Work (SOW) to carry out a Travel Behavior Trend Analysis for the Miami-Dade County Transportation Planning Organization (TPO). The study will look to assess, compare, and identify trends in travel patterns prior to the COVID-19 pandemic, during the pandemic related lockdowns ("shelter-in-place" or "stay-athome" orders), and after the phased reopening of Miami-Dade County. The primary goal of this effort is to assist the TPO with understanding the impact that the pandemic has had on those that utilize the surface transportation networks in Miami-Dade County, and project future travel behaviors and how these behavioral shifts may impact transportation demand.

SOUTH FLORIDA REGIONAL TRANSPORTATION AUTHORITY (SFRTA)

The findings and recommendations of the Council's "TOD Readiness Report for Select Station Areas" (Report) is providing guidance and direction for the issuance of Requests for Proposals (RFPs) for SFRTA-owned land in station areas. The Report was produced by Council staff in collaboration with SFRTA staff and the Treasure Coast Regional Planning Council (TCRPC). The RFPs are expected to be focused on the three stations that were found in the Report to have immediate market potential (Boca Raton, Boynton, and Cypress Creek Stations) but may be more broad ranging to maximize benefits to the SFRTA. The goal of the effort is to activate station areas, increase ridership, and maximize the benefits to the SFRTA of underutilized land. Click here for more information.

EDA CARES ACT REVOLVING LOAN FUND PROGRAM

The Council has begun operation of the EDA CARES Revolving Loan Fund (RLF), hired key program staff, and submitted a two-year grant administration plan to the Economic Development Administration. The RLF CARES Act Program is a long-term financing program to assist COVID-19 impacted businesses to alleviate sudden and severe economic disruption caused by the pandemic in the four-county area of Monroe, Miami-Dade, Broward, and Palm Beach counties. FLORIDA STATEWIDE REGIONAL EVACUATION STUDY PROGRAM

The Council staff is working with the Northeast Florida Regional Council in collaboration with the other eight Florida RPCs to continue the combined efforts in the Statewide Regional Evacuation Study Program. This round, Council staff's primary responsibility will involve revisiting the Behavioral Study (i.e. will people evacuate, what will it take for them to evacuate, will repeated storms increase the likelihood of evacuations, will "false alarms" have the opposite effect, etc.). The effort will also involve updating GIS data such as demographics and location of shelters for inputs in the state evacuation model. The project will be completed June 30, 2021.




COMPREHENSIVE ECONOMIC DEVELOPMENT STRATEGY (CEDS)

As the South Florida Region's Economic Development District, the Council has the responsibility of updating the region's CEDS document every five years, to cover 2022 - 2027. Council staff has started preparing to invite the next CEDS Strategy Committee to convene under the leadership of the Council to formulate an for approach revitalizing the economic development strategy of the region. Discussion will incorporate the new recommendations by the Development Administration to Economic increase the focus on economic resiliency, as well as, take advantage of the newly created Opportunity Zones. Over the next 16 months, Council staff will convene with the CEDS Strategy Committee multiple times to gather input that will guide economic development investment. Click here for more information.

PUBLIC MARINA & COASTLINE RESILIENCE / BROWNFIELDS INITIATIVE

The South Florida Regional Planning Council, Treasure Coast Regional Planning Council, and Miami Waterkeeper are working together as a Coalition to improve coastal resiliency and reduce environmental impacts at public marinas and coastline access points.



The Coalition seeks to assess potential environmental impacts and resiliency challenges, while helping communities to move priority sites forward with cleanup and resiliency planning, design, and implementation. Click here for more information.

SOUTH DADE ECONOMIC DEVELOPMENT STRATEGY

Council staff secured over \$200,000 in funding for Miami-Dade County from the U.S. Economic Development Administration for the creation of the South Dade Economic Development Strategy. Staff has been working with Miami-Dade Department of Regulatory & Economic Resources (RER), Lambert Advisory, and the Economic Development Council of South Miami-Dade (EDC) to develop a strategic plan for South Miami-Dade. The project team solicited information from key industries in the region. These included stakeholders from the retail, healthcare, and agricultural industries in South Miami-Dade. Their insights, along with community feedback, will strengthen the finalized strategic plan.

SFRPC RECOGNIZED AS "COMMUNITY PARTNER OF THE YEAR" BY THE U.S. SMALL BUSINESS ADMINISTRATION

SOUTHEAST FLORIDA & TAMPA BAY CLEAN CITIES COALITIONS TEAM UP ON VEHICLE TECHNOLOGIES

The Southeast Florida Clean Cities Coalition and the Tampa Bay Clean Cities Coalition met on Wednesday, November 20, 2019 at the Hilton Miami Downtown for an informative session on automated, connected, electric, and shared (ACES) technologies. With the advent of these technologies, collaboration with regional stakeholders is important to ensure cohesive implementation. The workshop included guest presentations from experts in urban and regional planning, automated vehicle deployment, and advanced vehicle technologies.

TRANSIT-ORIENTED DEVELOPMENT (TOD) WORK PROGRAM – SFRTA PROFESSIONAL SERVICES AGREEMENT

Council staff provided ongoing community engagement and technical assistance to further the of encouraging Transit Oriented Development (TOD) around existing Tri-Rail stations. The Report found that there were stations along the corridor with immediate potential for TOD joint development on publicly owned land and several with longer term opportunities. The Council assisted in designing a Request for Proposal (RFP) process for joint developments on the SFRTA owned lands and RFPs are now being released. The Council also executed a new five-year professional services agreement between the SFRPC and the SFRTA for the period of 2020 -2025 as the same level of support as the previous agreement. The initial tasks to be funded by the agreement have been identified as part of the mutually agreed upon TOD Work Program. The Council has been an integral partner, along with the Treasure Coast Regional Planning Council, in the planning that the SFRTA undertakes in support of regional mobility in Southeast Florida.

2019-2020 ECONOMIC IMPACT STUDY FOR FORT LAUDERDALE ALLIANCE

Through the Southeast Florida Economic Forecasting Partnership, the SFRPC continues to produce for the Greater Fort Lauderdale Alliance its steady annual economic impact analysis of the jobs created and retained by the Alliance's efforts from 2019-2020. The Forecasting Partnership allows Council staff to use software from the Regional Economic Modeling Institute (REMI) to produce an estimate of the total economic impact of the specific types and number of jobs that the Alliance helped to create and retain.

THE HAZARDOUS MATERIALS EMERGENCY PREPAREDNESS (HMEP) GRANT

Starting in 1993, the Pipeline and Hazardous Materials Safety Administration began awarding grants to States, Territories, and Native American Tribes. The grant program, Hazardous Materials Emergency Preparedness (HMEP) Grant, was designed to "develop, improve, and carry out emergency plans" within the National Response System and the Emergency Planning and Community Right-To-Know Act of 1986. The SFRPC and South Florida Local Emergency Planning Committee (LEPC) are proud to assist the Florida Department of Emergency Management in utilizing these funds for the South Florida region including in Broward, Miami-Dade, and Monroe counties. This grant program plays a key role in the objective of increasing resiliency across South Florida communities, especially regarding hazardous materials emergencies. The LEPC is also working to assist Broward County's Environmental and Consumer Protection Department by delivering OSHA HAZWOPER refresher courses in March. We are pleased to play a part in the increasing focus on raising resiliency and emergency preparedness in South Florida.



SOUTHEAST REGIONAL DOMESTIC SECURITY TASK FORCE

The overall mission of the Southeast Regional Domestic Security Task Force (SERDSTF) is to protect Region 7 (Southeast Florida) from terrorist or homegrown attacks, and if attacked, furnish response assistance in the most efficient manner possible.



The state's seven (7) Regional Domestic Security Task Forces (RDSTFs) are the foundation of Florida's domestic security structure.

Each RDSTF is co-chaired by a local Sheriff or Police Chief and an FDLE Special Agent in Charge (SAC). Task force members include first responders from the disciplines of fire/rescue, emergency management, public health and hospitals, as well as law enforcement. The task forces also work in partnership with schools, businesses, and private industries. By utilizing a multi-disciplinary approach, the RDSTFs provide support to impacted communities by serving as a force multiplier for local agencies and working in conjunction with emergency management professionals.

Over the past few years, the SERDSTF has hosted several exercises to help prepare and train the region's first responders in events such as domestic and international terrorism, active shooter, plane crashes, natural disasters, and more.

- ❖ Operation Heatshield II was designed and organized to test Southeast Florida's terrorist response resources and rescue efforts. Organized as a very large-scale drill, more than 20 agencies participated in the exercise, many deploying their terrorist response equipment and personnel. More than 100 participants participated over the nearly two-day event in April 2018. Players were formed into four separate task forces and were charged with detailed operations while responding to a terroristic threat at multiple locations.
- 2017 Miami EOC Exercise was a discussionbased tabletop exercise. This five-hour exercise discussion centered around the response to a terroristic threat involving active shooters and improvised explosive devices (IED's) at Marlins Park.

During this discussion at Miami's Emergency Operations Center, regional terrorist response teams held an open dialogue on many issues regarding response capabilities. Some of these capabilities included Public Information and Warning, Mass Care Services, and Situational Assessment. These types of exercises serve as a great way to initiate and increase coordination if a regional response is ever necessary.

Operation Heatshield III kicked off on May 15, 2019, as the SERDSTF's annual terrorist response exercise. This exercise lasted two days and included over 50 response agencies from the local, state, and federal level. Heatshield exercise consisted of a main goal to test response capabilities at the major seaports in the region: Port of Miami, Port Everglades, and the Port of Palm Beach. Responders were exceptional in exercising their coordinated response efforts, utilizing the incident command system, and implementing interoperable communications.

The SERDSTF continues to monitor the COVID-19 pandemic and remains hopeful that planning for the next full-scale exercise will begin in 2021.

REGIONAL PLANNING COUNCIL'S SUPPORT FLORIDA'S CORAL REEF CAMPAIGN

Over the last three years the South Florida RPC and Treasure Coast RPC have worked with the Florida Department of Environmental Protection and public, private, and nonprofit stakeholders to further public awareness, restoration, and protection of Florida's endangered coral reef spanning Miami-Dade through Martin counties, and Monroe County. In January 2020, the Councils were among those who welcomed Governor DeSantis to Frost Museum of Science for the launch of Florida's Coral Reef campaign.





TRADITIONAL REVOLVING LOAN FUND CONSOLIDATION PROGRAM



The South Florida Regional Planning Council Revolving Loan Fund Programs (SFRPC-RLF) were first established with several public and private agencies before being transferred to the SFRPC.

The RLFs were created as a result of the devastation of Hurricane Andrew, which on August 24, 1992 ravaged large tracts of Miami-Dade County. Hurricane Andrew stands as one of the most damaging and costly natural disasters in the history of the United States, surpassed only by Hurricane Katrina in 2005.

Many businesses, especially in the southern area of the county, faced insolvency after commercial and industrial buildings, agriculture land and tourist facilities were destroyed by the hurricane. Although recovery from Hurricane Andrew is no longer the most urgent economic development priority for the South Florida region, many small/medium size businesses seeking financial capital to grow their businesses are unable to obtain traditional financing from conventional lenders. However, as the regional economy grows, the SFRPC Revolving Loan Fund has served as an instrument to strengthen and achieve the stated goals of the SFRPC Comprehensive Economic Development Strategy (CEDS).

The SFRPC knows that the best economic development plan for the region is to develop its small and medium size businesses. The SFRPC focuses its economic development activities on technical assistance and capacity building, enhanced coordination, communication, and infrastructure development. In our judgement, these activities provide the greatest long-term return on investment and are the best use of limited resources. Click here for more information.

COVID-19 ECONOMIC RECOVERY ASSISTANCE AVAILABLE

The South Florida Region has seen a massive impact on our economy due to COVID-19. The South Florida Regional Planning Council is here to be a source of information, resources & initiatives important for the speedy economic recovery of our region.

SOUTH FLORIDA AND TREASURE COAST LEADERS HELD JOINT VIRTUAL MEETING TO DISCUSS ISSUES OF REGIONAL IMPORTANCE

The South Florida and Treasure Regional Planning Councils (RPCs) met virtually via GoToMeeting on Friday, October 16th at 10:00 a.m. in Joint Session. The meeting was co-chaired by The Honorable Steve Geller, then First Vice Chair South Florida RPC, and Council Member Michael Houston, Chair Treasure Coast RPC. The Council's considered testimony and discussed the Future Water Supply for Southeast Florida; Biscayne Bay's Recovery Plan Case Study; Southeast Florida's Coral Reef Ecosystem Conservation Area Water Quality Monitoring Program; an update on Florida's Coral Reef. The Council's successfully and unanimously adopted Joint Resolution TCSF #20-01, supporting funding and proposed legislation for Florida's Coral Reef, including passage of the federal Restoring Resilient Reefs Act of 2000, and renaming the Southeast Florida Coral Reef Ecosystem Conservation Area in honor of the late Representative Kristin Jacob in recognition of her unwavering commitment to the coral reef and environment.

Also discussed was an innovative technology to remove biomass and accumulated nutrients from water, and Florida's Water Challenge with respect to needed infrastructure and insufficient funding. <u>Joint Resolution TCSF #20-02</u> and <u>TCSF #20-03</u>, respectively addressing water/wastewater infrastructure investment and biosolids management, were passed without objection. Lastly, the Councils discussed Affordable Housing and adopted <u>Joint Resolution TCSF #20-04</u> which urges the Florida Legislature to continue to support local housing programs by appropriating 100% of the monies deposited in the State and Local Housing Trust Funds for housing for Fiscal Year 2021-2022. The public was encouraged to attend and contributed a number of comments to show their support for the advancement and improvement of South Florida waterways. 
FY 2019 - 2020
