The Honorable Steve Geller, Chair, SFRPC Broward County Commissioner, District 5, and Former State Senator



Senator Steve Geller served as Broward County Mayor during FY 2021. Elected to District 5 in 2016, he currently represents all or part of Cooper City, Southwest Ranches, Davie, Plantation, Sunrise, and unincorporated areas including part of the Seminole Reservation and all of Broadview Park. Geller serves as Chairman of the Broward County Water Advisory Board, Chair of the South Florida Regional Planning Council, and serves on the Executive Committee of the Florida Association of Counties (FAC) and on the Broward County Cultural Council. Geller also serves as Chair of the South Florida CEDS Strategy Committee established pursuant to the SFRPC's responsibilities as U.S. EDA's Economic Development District for South Florida. He was recently re-elected Chair by his colleagues on the SFRPC.

Prior to his current service as a Broward County Commissioner, Geller was elected to the Florida Legislature in 1988 at the age of 29. He served in the Florida Legislature for 20 years; nine years in the House of Representatives followed by 11 years in the Florida Senate. Geller was respected by both Political Parties and chaired legislative committees under the leadership of both Democratic and Republican Presiding Officers. Geller chaired the Regulated Industries Committee in the House of Representatives, and the Agriculture and Consumer Services and the Community Affairs Committees in the Senate. Geller served two terms as Chair of the Broward County Legislative Delegation and two terms as Chair of the Hendry County Legislative Delegation. At the time of his retirement from the Florida Senate due to term limits, Senator Geller was the Minority (Democratic) Leader of the Florida Senate. Geller has also served as National President of two legislative organizations: the National Conference of Insurance Legislators (NCOIL) and the National Council of Legislators from Gaming States (NCLGS). Geller was born in the City of New York, New York in 1958. He has lived in South Florida since 1965. He attended Florida State University for college and law school, where he was a member of AEPi Fraternity. He has lived in South Broward since his graduation from Florida State University College of Law in 1982. He is married to Laurel Geller and they have two children Marc and Ben.

He is the Chair of the City of Fort

Lauderdale's Transportation Management Agency, which is morphing into a commuter services arm and had previously operated a local circulator which had an annual ridership exceeding 650,000 passengers, operating seven routes and one water trolley route. Greg brings over 34 years of experience working in both the public and private sector. His public sector experience includes progressively responsible management at the municipal, county and state levels. Gregory has focused on land use, transportation and environmental planning. He has secured millions of dollars in Federal appropriations for major transportation projects, modified state rules to facilitate traffic mitigation, stimulated redevelopment efforts and helped implement a dynamic water reuse project in West Palm Beach. Greg's private sector experience includes component manufacturing, logistics, zoning and land use. He thanks University of Pittsburgh and Florida State University for his education that built his career.

Jonathan Hopkins, Founder, Smart Mobility Associates



Jonathan founded Smart Mobility Associates to empower thriving communities to grow without degrading travel and quality of life. Jonathan's work has helped America's fastest growing places add jobs while simultaneously reducing traffic.

Jonathan previously served as the VP of Mobility at <u>Brightline</u> and the Executive Director of <u>Commute Seattle</u>.

At Brightline, Jonathan implemented the \$20 million <u>Brightline+</u> first/last mile station connectivity program successfully implemented in 2021 to spur rail ridership growth through branded EVs, microtransit and bikeshare. In 2022, he spearheaded integration of

Uber to increase service reliability and cost effectiveness accruing millions in cost savings.

At Commute Seattle, he led a 14-person team to partner with businesses and public agencies to promote smart mobility choices and reduce drive-alone rates. During his tenure, Commute Seattle reported that only 25% of Downtown Seattle workers drove alone to work, indicating Seattle added 60,000 jobs yet reduced SOV use by 4,500 in just seven years.

Jonathan's career has also included work at Lime as a policy director for Canada and the Mountain West and at Uber covering policy and operations in the Pacific Northwest. In a volunteer capacity, Jonathan spent the last 8 years as an executive director and political director with <u>Seattle Subway</u>, leading a successful effort to <u>double</u> the size of Sound Transit's 2016 \$54 billion 116-mile light rail<u>ST3 expansion package</u>. He was also founder of <u>Cascadia Rail</u>, a high speed rail advocacy group in the Pacific Northwest. Jonathan has degrees from Georgetown and the US Military Academy at West Point and served in the US Army in both Iraq and Afghanistan, where he was awarded a Bronze Star with V device for Valor. A Washington State native, Jonathan is based in Miami.
