Gayle Harrell

The Honorable Gayle Harrell represents Florida Senate District 31, which includes Martin and St. Lucie counties and part of Palm Beach County. She was elected to the Florida Senate in November 2018 after serving eight terms in the Florida House of Representatives from 2000-2008 and 2010-2018. Senator Harrell has over 25 years of experience in healthcare. She worked as a Healthcare Administrator, managing the Ob-Gyn practice of Dr. James E. Harrell and was the founder of the Breast Imaging Center, a mammography center specializing in preventive care for women. Her experience in healthcare has made her a leader in setting healthcare policy for the State of Florida. Senator Harrell is Chair of the Committee on Health Policy and Vice Chair of the Appropriations Subcommittee on Health and Human Services. Senator Harrell is also a member of the Appropriations Subcommittee on Criminal and Civil Justice; Children, Families, and Elder Affairs; Military and Veterans Affairs and Space, and the Joint Committee on Public Counsel Oversight. Senator Harrell has won numerous awards for her legislative service. Among her many awards she has received the Legislator of the Year by the Florida Medical Association, the Legislative Leadership Award by Mothers Against Drunk Driving, the Legislative Award by the Florida Children's Forum, an "A" Ranking by the Florida Chamber of Commerce, the Friend of Free Enterprise Award by the Associated Builders and Contractors, the Legislative Achievement Award by Keep Florida Beautiful, and the Distinguished Legislator Award by the Florida Police Benevolent Association. She has been recognized at the national level as Legislator of the Year by Health Information Systems Society (HIMSS) and Exceptional Legislator Award by the Schizophrenia & Related Disorders Alliance of America (SARDAA).

A resident of Florida's Treasure Coast for over 49 years, Senator Harrell is committed to serving our community having served on the boards of many local civic organizations such as Hibiscus Children's Center, Education Foundation of Martin County, Big Brothers Big Sisters of St. Lucie, Indian River, and Okeechobee Counties, HPS – Helping People Succeed and advisory board member of the Center for Constitutional Values. She holds a Bachelor's Degree in Spanish and a Master's Degree in Latin American History from the University of Florida where she received the Edith Bristol Tigert Award as an Outstanding Female Graduate and was elected to Phi Beta Kappa.



Steve Geller

The Honorable Steve Geller Chair, SFRPC; Former State Senator, District 31; Broward County Commissioner, District 5 Senator Steve Geller served as Broward County Mayor during FY 2021. Elected to District 5 in 2016, he currently represents all or part of Cooper City, Southwest Ranches, Davie, Plantation, Sunrise, and unincorporated areas including part of the Seminole Reservation and all of Broadview Park. Geller serves as Chairman of the Broward County Water Advisory Board, Chair of the South Florida Regional Planning Council, on the Executive Committee of the Florida Association of Counties (FAC) and on the Broward County Cultural Council. Geller also serves as Chair of the South Florida CEDS Strategy Committee established pursuant to the SFRPC's responsibilities as U.S. EDA's Economic Development District for South Florida. Prior to his current service as a Broward County Commissioner, Geller was elected to the Florida Legislature in 1988 at the age of 29. He served in the Florida Legislature for 20 years; nine years in the House of Representatives followed by 11 years in the Florida Senate. Geller was respected by both Political Parties and chaired legislative committees under the leadership of both Democratic and Republican Presiding Officers. Geller chaired the Regulated Industries Committee in the House of Representatives, and the Agriculture and Consumer Services and the Community Affairs Committees in the Senate. Geller served two terms as Chair of the Broward County Legislative Delegation and two terms as Chair of the Hendry County Legislative Delegation. At the time of his retirement from the Florida Senate due to term limits, Senator Geller was the Minority (Democratic) Leader of the Florida Senate. Geller has also served as National President of two legislative organizations: the National Conference of Insurance Legislators (NCOIL) and the National Council of Legislators from Gaming States (NCLGS).

Geller was born in the City of New York, New York in 1958. He has lived in South Florida since 1965. He attended Florida State University for college and law school, where he was a member of AEPi Fraternity. He has lived in South Broward since his graduation from Florida State University College of Law in 1982.



Maria Marino

Elected to the Palm Beach County Commission on November 3, 2020, Maria Marino currently serves as Vice Mayor. She previously served on the Palm Beach Gardens City Council from 2016–2020, and was the City's Mayor in 2017 & 2018. Maria is Chairman of the Solid Waste Authority, the Pal Mar Water Control District and Bioscience Land Protection Advisory Board, is Vice Chair of the Palm Beach County Transportation Planning Agency and Chairman of the Treasure Coast Regional Planning Council. She is a board member of the Loxahatchee River Management Coordinating Council, the 16-County Coalition for Lake Okeechobee, and the Florida Association of Counties(FAC). Maria is a Policy Leader on the FAC Community and Urban Affairs Policy Committee, and is Vice Chair of the Finance and Tax Committee. She serves on the National Association of Counties Environment, Energy and Land Use steering committee. She is the past Chair of the South Florida Regional Transportation Authority. She is also a 2019 Women of Excellence Award Honoree by the National Foundation of Women Legislators. Additionally, she received the 2020-21 and 2022-23 Presidential Advocacy Award from FAC. Maria is the 2023 Leadership Excellence Award winner of Leadership Palm Beach County (LPBC) and a graduate of the Class of 2010. She has served on its Board of Directors, chaired several committees, and continues to participate as a panelist and moderator for several LPBC events throughout the year. The 2017 "Woman of the Year" by the Palm Beach North Chamber of Commerce, Maria is also a mentor and panelist with the Chamber's Women in Business Mentorship Boot camp, sits on several subcommittees and is a Past Trustee Member. Maria was the Broker/Owner of Marino Realty Group and served as the Executive Director of the Jupiter Children's Foundation for over 20 years. With a strong belief in community service and philanthropy, she has supported many initiatives targeted at enriching the lives of at-risk youth and building business relationships that benefit those in need. In this capacity, Maria has been involved with over 30 local nonprofits, is a member of the University of Connecticut's Women and Philanthropy organization, and is a member of Impact of the Palm Beaches. Additionally, Maria serves as a Board Member with the Children's Golf Foundation and The First Tee of the Palm Beaches, is a past board member and President of the Edna W. Runner Tutorial Center and continues to serve as an Ambassador with the Honda Classic. She also co-chaired Palm Beach County Cares, a disaster relief organization and served as a Board Member with the Forum Club of the Palm Beaches. Maria has been the guest speaker at state and national conferences, and most recently served as the Keynote Speaker for the Miami Women Leaders Conference. She also serves as the emcee for the Annual Melanoma Foundation Charity Luncheon. A native of Connecticut and a graduate of the University of Connecticut, Maria won the State Women's Amateur Golf Championship in 1985. She came to Florida to improve her golf skills and never left the Sunshine State. As a nearly 30-year member of the Ladies Professional Golf Association, Maria has been a mentor with the LPGA, served on the organization's National Marketing Committee, and was Southeast Section Treasurer. She was the Director of Instruction for the Joanne Carner Golf Academy and mentored many other LPGA members in that capacity. She is also a 20-year member of the Golf Writers Association of America, with works published locally and nationally. Maria is also a 2019 Honoree of the Norwalk, Connecticut Old Timers Athletic Association that recognizes hometown heroes who have distinguished themselves in sports and beyond.

As Lieutenant Governor Jeff was Chairman of the Board of Space Florida, Chairman of Florida's Children and Youth Cabinet, Chairman of the Florida Sports Foundation, and had oversight responsibility for the Governor's Office of Drug Control, the Office of Adoption and Child Protection, the Department of Highway Safety and Motor Vehicles, as well as the Governor's Film and Entertainment Office. On June 18, 2008 Governor Kottkamp became Acting Governor of the State of Florida pursuant to a Proclamation filed with the Secretary of State transferring power to him pursuant to Article IV Section 3(b) of the Florida Constitution.

Governor Kottkamp served in the Florida House of Representatives from 2000 to 2006. While serving in the House, Jeff was chairman of the Judiciary Appropriations Committee (2006), chairman of Government Operations Committee (2005), chairman of Judiciary Committee (2002–2004), and vice-chairman of the Rules and Calendar Council (2004–2006). He also served as Deputy Majority Whip. As a member of the Florida Legislature, Kottkamp had a reputation for fighting for lower taxes. He sponsored legislation to repeal the Intangibles Tax. He helped form the "Freedom Caucus" in the House. Caucus members opposed any efforts to raise taxes. Governor Kottkamp served as Co-Chair of the Taxpayer Protection Caucus. Jeff currently serves on the Board for the Florida Historic Capitol Foundation, is a Trustee of the Florida Supreme Court Historical Society and a member of the Economic Club of Florida.

His specialization is Environmental Engineering, specifically solid and hazardous waste management, water quality, wastewater engineering, drinking water treatment, air quality, watershed management, public health engineering, and pollution prevention. As Dean, he also focuses on Undergraduate Research, Educational High-Impact Practices, and Student Success Initiatives at the University level. Dr. Meeroff is the founder and director of the Laboratories for Engineered Environmental Solutions (Lab.EES) (http:\\labees.civil.fau.edu).

He has over 26 years of experience in environmental issues with over \$12 million in funded research and 120 publications.

Tyler Moroles has over 10 years of experience in the affordable housing sector, having worked with organizations such as the Minneapolis Public Housing Authority, Hennepin County Department of Community Development, and the Office of U.S. Congressman Danny K. Davis (IL-7). Currently, he serves as the Assistant Division Director of the Section 8 Housing Choice Voucher Program for Miami-Dade County, he has worked in the county for over 3 years in several roles. Tyler holds a Master's degree from Columbia University in the City of New York and a Bachelor's degree from DePaul University. Outside of work, he enjoys fitness and language learning, including Spanish, Portuguese, and Arabic. Tyler has a personal connection to senior issues, having spent time in nursing homes where his mother worked.



Naushira Pandya

Dr. Naushira Pandya is Professor and Chair of the Geriatrics Department at NSU, Kiran C. Patel College of Osteopathic Medicine, and the Project Director of the HRSA funded NSU South Florida Geriatrics Workforce Enhancement Program (GWEP). She is board-certified in Internal Medicine, Geriatrics, and Endocrinology and Metabolism, and is a certified medical director and a geriatrics fellowship program director. Dr. Pandya has created a thriving academic, and clinical department, comprised nursing homes, Medical Director leadership, ACGME-accredited geriatrics fellowships, two Geriatrics Clinics, as well as well as strong inter-professional institutional and community partnerships. At a state level, she is First Vice President of the Broward County Area Agency on Aging, and past board member of the Florida Society for Post-Acute and Long-Term Care Medicine, and remains active in governance issues affecting the post-acute long-term setting.

Dr. Pandya is Past President of AMDA, the national Society for Post-Acute and Long-Term Care Medicine, and past chair of the interdisciplinary Clinical Practice Committee. She has participated and led in the development of multiple clinical guidelines and position statements, and is a recognized for her work in the area of diabetes in the elderly, as well as best practices in the long-term care continuum. On a national level, she was a panelist in the White House Conference on Aging, and in the White House Conference on Antibiotic Stewardship, and served on Physician's Advisory Committee for the National Quality Forum, and as a member of College of Surgery Coalition for Quality in Geriatric Surgery. She is a board member of the National Association for Geriatric education, and a member of the HHS Advisory Committee on Interdisciplinary and Community-Based Linkages. Dr. Pandya holds the distinction of being a Fulbright Senior Specialist Scholar.



Nan Rich

Senator Nan Rich was first elected as Broward County Commissioner, District 1 in 2016 and re-elected, unopposed, in 2020. She was recently selected by her colleagues on the County Commission to be the Mayor of Broward County through November 2024. Her top priority has been addressing the affordable housing crisis in Broward, as well as ending homelessness through affordable housing.

Prior to her service on the County Commission, Nan Rich was elected to the State Senate in 2004 after serving two terms in the Florida House of Representatives. She was recognized as one of the most passionate and dedicated members of the Florida Legislature, and she was the first woman to be elected Senate Democratic Leader – a position she held from 2010 until she was term-limited in November 2012. Her community involvement includes years of advocacy and activism on behalf of women, children, and families. Prior to her election to the State Legislature, Nan Rich served as the National President of the National Council of Jewish Women, the first Floridian elected to that office. She was also honored to receive an appointment by President Bill Clinton to serve as a Member of the United States Holocaust Memorial Museum Council in Washington, DC.

In addition to her work on the County Commission, Senator Rich currently serves as the President of the Area Agency on Aging of Broward County, Chair of the Broward Behavioral Health Coalition, and Chair of the Coordinating Council of Broward County. Among her long list of awards and honors, Senator Rich has been inducted into the Broward County Women's Hall of Fame, the Broward County Senior Hall of Fame, and the Miami Beach High School Hall of Fame. A long-time Florida resident, Nan attended the University of Florida.



Max Rothman

Max B. Rothman joined the Alliance for Aging, Inc. in April 2007 as President and Chief Executive Officer to provide leadership and direction for programs for older adults in Miami-Dade and Monroe Counties, Florida. The Alliance administers approximately \$55,000,000 through community agencies that provide a variety of in-home and community-based services to elders. The Alliance serves as the focal point for aging issues and is home to the Aging and Disability Resource Center that provides access to services through information, referral, intake for elders and adults with disabilities, and their caregivers, as well as coordination of eligibility for the Medicaid Managed Long Term Care Program.

He has forty-seven years of experience in the field of aging. Prior to joining the Alliance, he was founder and Executive Director for 24 years of The Center on Aging, Robert Stempel School of Public Health, in the College of Health and Urban Affairs. The Center engaged in research, education and training on issues of aging. During his tenure, he also served as Acting Director of the School of Social Work, College of Urban and Public Affairs at Florida International University. From 1975 to 1983, he served as the first District Administrator of the Florida Department of Health and Rehabilitative Services in Miami-Dade and Monroe Counties and was responsible for administration of nine state health and social services programs. Before joining the State of Florida, he served as Executive Director of three legal services programs for the indigent in New Jersey, Florida and Colorado.

He served as a Peace Corps volunteer from 1966 to 1968, working for the municipal government of Barcelona, Venezuela on issues of land taxation, public works, and garbage collection. He received a Juris Doctor from the University of Michigan Law School and a Master of Laws from The George Washington University Graduate School of Public Law. He earned his B.A. degree in Government and Law from Lafayette College. Rothman also completed the Program for Senior Executives in State and Local Government at the Kennedy School of Government of Harvard University. He has received numerous awards including the 2012 Path Award for Health Policy and Management from the Robert Stempel College of Public Health and Social Work at Florida International University, and the 2015 Dr. Carter Osterbind Outstanding Florida Council on Aging Member.



Chris Stephenson

As Transportation Director, Chris Stephenson oversees everything related to the GoLine, Community Coach, Martin Community Coach and the Advantage Ride Program for Senior Resource Association (SRA). Chris loves seeing how transportation options and mobility can greatly improve the quality of life for all members of a community from children to the elderly.

A proud Texan, Chris was born and raised in the Lone Star State. Chris received his bachelor's degree in Communication and his Master's in Non-Profit Business Management from Abilene Christian University. Chris' Master's thesis was in partnership with multiple hospitals and explored the correlation between Self-differentiation levels in employees that worked in healthcare, and burnout. Laura Streed is a Sr. Associate State Director for Advocacy and Livable Communities. She leads AARP Florida's work on livable community issues and the state's local advocacy efforts on housing and transportation. Mr. Weir founded Eastwind Development in 2007 and has served as President/CEO since then. Eastwind is based in Palm Beach Gardens with a second office in Orlando. He was chairman of the successful campaign to persuade the voters of Palm Beach County to approve the \$200 million housing bond in November 2022, and worked closely with the County Commission and staff on the recent approval of the County-wide Housing For All Plan. He also chairs the Workforce Housing Subcommittee of the Economic Council. He is a graduate of Harvard Law School and is a member of the Florida Bar.

### **ABOUT US**

The South Florida Regional Planning Council (SFRPC) is one of Florida's ten regional planning councils. Created by the region's counties by Interlocal Agreement, and by the Florida Legislature in Chapter 186, Florida Statutes, the SFRPC serves Monroe, Miami-Dade, and Broward counties, 70 municipalities and more than 4.7 million residents. The SFRPC is governed by a 19-member board of county and municipal elected officials, and gubernatorial appointees. Representatives from the South Florida Water Management District, Florida Department of Transportation Districts 4 and 6, and Florida Department of Environmental Protection serve as ex-officio members.

As a regional planning and public policy agency, a principal and unique role of the SFRPC is to identify the long-term challenges and opportunities facing South Florida, and convene public, private, non-profit, and other civic leaders in collaborative regional partnerships to develop strategies and take action to maximize opportunities and overcome challenges. The SFRPC works with its local governments, and regional, state and federal agencies to provide planning support and technical assistance in myriad planning areas.

The SFRPC's planning services include affordable housing, transportation, transit-oriented development, brownfields remediation and redevelopment, community resilience, water quality and supply, Florida's Coral Reef, alternative and clean fuels, emergency planning and response, community and military installation resilience, economic and demographic modeling, and economic development among others. As the Economic Development District for South Florida, established in 1996 by the U.S. Department of Commerce Economic Development Administration, the SFRPC is responsible for the development of the Comprehensive Economic Development Strategy for South Florida, and supporting business creation and expansion of employment opportunities. In its economic development role, the SFRPC operates multiple revolving loan funds which support small business development and expansion, the development of affordable single-family housing, and the remediation and redevelopment of brownfield sites.

The SFPRC and TCRPC enjoy a long-standing collaborative partnership and productive history of working together to address the challenges and opportunities facing Southeast Florida. This larger region consists of Monroe, Miami-Dade, Broward, Palm Beach, Martin, St. Lucie, and Indian River counties. Joint topics of exploration include waste management and recycling, water infrastructure, affordable housing, regional transportation, Florida's Coral Reef, Central and Southern Florida Flood Resiliency Study, and The Silver Tsunami: Planning and Policy Solutions for Southeast Florida's Communities.
