SOUTH FLORIDA AND TREASURE COAST REGIONAL PLANNING COUNCILS WILL MEET FRIDAY, FEBRUARY 28TH IN JOINT SESSION TO DISCUSS FLORIDA'S CORAL REEF, LEGISLATIVE PRIORITIES, ENVIRONMENTAL RESILIENCE, AND TRANSPORTATION INITIATIVES IMPACTING SOUTHEAST FLORIDA

Hollywood, FL – The South Florida and Treasure Coast Regional Planning Councils (SFRPC and TCRPC) will meet this Friday, February 28, 2025, from 10:00 a.m. to 3:00 p.m. at the Broward County Metropolitan Planning Organization, located at 100 West Cypress Creek Road, Suite 650 (TRI-RAIL Cypress Creek Station), in Fort Lauderdale.

The meeting will be co-chaired by **The Honorable Michelle Lincoln**, Chair of the South Florida Regional Planning Council and Monroe County Mayor Pro Tem, and **The Honorable Ed Dodd**, Acting Chair, and Secretary-Treasurer of the Treasure Coast Regional Planning Council. Since 2017, the SFRPC and TCRPC have convened Joint Council Meetings and Regional Conferences to discuss opportunities and challenges facing the region, and collaborative approaches across Southeast Florida.

"We are delighted to host our colleagues from the Treasure Coast RPC in Broward County this year. We appreciate our long history of successful collaboration on important issues of regional concern including property insurance, Florida's Coral Reef, waste management and recycling, affordable housing, water quality and infrastructure, the Central and Southern Florida Flood Risk Study, the Silver Tsunami, and regional transportation to name a few. We look forward to our conversation and informative presentations from our key state and regional partners," said Chair Michelle Lincoln, Mayor Pro Tem, Monroe County.

"The opportunity to share information and work collaboratively with our neighbors to the south on issues of mutual concern is not to be missed," said Ed Dodd, Acting Chair, and Secretary-Treasurer, TCRPC.

This regional conversation will focus on several key topics. These topics include an update on Florida's Coral Reef, the Biscayne Bay Reasonable Assurance Plan, a preview of the 2025 State of Florida Legislative Session, an overview of Southeast Florida Counties' legislative programs and priorities, a South Florida Regional Transportation Authority (SFRTA) / Tri-Rail update and future plans, and discussions on Southeast Florida's restoration and flooding resilience, including current studies, projects, and timelines.

Book, Founder, President & CEO of Ronald L. Book, P.A.; David Dech, Executive Director of the South Florida Regional Transportation Authority; John Mitnik, P.E., Assistant Executive Director and Chief District Engineer for the South Florida Water Management District; Ana Carolina Coelho Marán, P.E., Ph.D., District Resiliency Officer for the South Florida Water Management District; and Eva B. Vélez, P.E., Chief of the Ecosystem Branch at the U.S. Army Corps of Engineers, Jacksonville District.

The Councils invite elected officials, stakeholders, and members of the public to participate in this critical conversation about the region's environmental resilience, infrastructure development, and collaborative planning strategies for Southeast Florida.
