## **THE HONORABLE MICHELLE LINCOLN**

Elected to the Monroe County Board of County Commissioners (District 2) in 2018, Michelle Lincoln chairs the South Florida Regional Council and serves on several committees, including NACo's Community, Economic and Workforce Development Steering Committee. She's the incoming President of the Florida Association of Counties (FAC), and she is a Certified, Advanced, and Advanced 2 County Commissioner graduate. Previously, Chair Lincoln served three years on the Marathon City Council, including one year as Mayor. A Monroe County resident since 1999, she previously worked as a Child Advocate Coordinator for the Guardian ad Litem Program and continues to volunteer. She received the 2018 Kay Gradick Woman of the Year Award and mentors with Take Stock in Children.

Chair Lincoln is a member of several local organizations, including Rotary and Chambers of Commerce, and an alumna of Leadership Monroe County. She holds a B.S. in Psychology from Northern Kentucky University and has two daughters, a son-in-law, and a dog.



## THE HONORABLE STEVE GELLER

Broward County Commissioner, District 5; Former State Senator; Immediate Past Chair, SFRPC; Chair, SFRPC CEDS Strategy Committee

Senator Steve Geller served as Broward County Mayor during FY 2021. Elected to District 5 in 2016, he currently represents all or part of Cooper City, Southwest Ranches, Davie, Plantation, Sunrise, and unincorporated areas including part of the Seminole Reservation and all of Broadview Park. Geller serves as Chairman of the Broward County Water Advisory Board, Former Chair of the South Florida Regional Planning Council, and serves on the Executive Committee of the Florida Association of Counties (FAC) and on the Broward County Cultural Council. Geller also serves as Chair of the South Florida CEDS Strategy Committee established pursuant to the SFRPC's responsibilities as U.S. EDA's Economic Development District for South Florida.

Prior to his current service as a Broward County Commissioner, Geller was elected to the Florida Legislature in 1988 at the age of 29. He served in the Florida Legislature for 20 years; nine years in the House of Representatives followed by 11 years in the Florida Senate. Geller was respected by both Political Parties and chaired legislative committees under the leadership of both Democratic and Republican Presiding Officers. Geller chaired the Regulated Industries Committee in the House of Representatives, and the Agriculture and Consumer Services and the Community Affairs Committees in the Senate. Geller served two terms as Chair of the Broward County Legislative Delegation and two terms as Chair of the Hendry County Legislative Delegation. At the time of his retirement from the Florida Senate due to term limits, Senator Geller was the Minority (Democratic) Leader of the Florida Senate. Geller has also served as National President of two legislative organizations: the National Conference of Insurance Legislators (NCOIL) and the National Council of Legislators from Gaming States (NCLGS). Geller was born in the City of New York, New York in 1958. He has lived in South Florida since 1965. He attended Florida State University for college and law school, where he was a member of AEPi Fraternity.

He has lived in South Broward since his graduation from Florida State University College of Law in 1982. He is the principal of Geller Law Firm, where he practices law primarily in the area of Zoning and Land Use. He is married to Laurel Geller and they have two children Marc and Ben.

Since 2018, Chad has led the development teams of 10 ground up commercial real estate projects totaling 594,000 square feet. As the lead for each project, he has taken developments from acquisition, thru design and construction, to disposition sales.

Prior to development, Chad was part of the financing team at Florida East Coast Industries (FECI) that secured \$533 million in commercial debt financing the Brightline Transit-Oriented Development (TOD). The TOD project included over 1,100 apartments, 290,000 square feet of office, and 170,000 square feet of retail at the Brightline train stations in Miami, Ft Lauderdale & West Palm Beach.

Ms. Lecour leads the initial due diligence, design, financial structuring, and negotiation of complex public-private partnerships (PPP) and nonprofit joint ventures to deliver transit-oriented affordable and workforce housing throughout South Florida.

With more than 19 years of experience, Ms. Lecour has overseen the development of over 50 multifamily communities totaling more than \$1.5 billion. She works closely with her team to identify and resolve issues early, creating value-added opportunities at every stage of development. Ms. Lecour specializes in complex neighborhood revitalizations and mixed-use, transit-oriented developments in collaboration with housing authorities, nonprofits, religious institutions, and municipal partners.

Her portfolio includes Florida's first LEED Silver and LEED for Homes Gold affordable housing developments, as well as one of the first LEED for Neighborhood Development projects in the U.S. She previously served as Housing Affordability Chair for the ULI Southeast Florida/Caribbean Management Committee.

Ms. Lecour earned an MBA from the Yale School of Management and a BA in International Relations from Stanford University, where she studied in Santiago, Chile. Outside of work, she chairs the Town of Surfside's Planning & Zoning Board.



## **ALBERT MILO, JR.**

President, Related Urban

Alberto Milo Jr. leads Related Urban Development Group (RUDG), the affordable and workforce housing division of the nation's most prolific development company, Related Group. In this role, he is responsible for the overall design, development, construction, financing and budgeting for each project within RUDG's portfolio, whether public, affordable, workforce or mixed-income housing.

Under Albert's leadership, RUDG has built and rehabilitated more than 5,700 units throughout Florida with over \$1.5 billion in total development costs.

Most recently, RUDG has begun an ambitious new set of projects which are designed to eliminate many of the drawbacks historically associated with public housing developments. Among these is the \$600 million River Parc master plan in Miami's Little Havana neighborhood, which is cited as the most ambitious affordable housing development in the county to date, built in partnership with Miami-Dade County. The development will contain over 2,500 units along with a new Riverwalk and commercial opportunities. Similarly, a \$400 million mixed-income riverfront development is underway in Tampa's historic West River district, developed in collaboration with the Tampa Housing Authority. Albert and his team are also currently working on the redevelopment of Liberty Square, the oldest and largest public housing development in the Southeastern United States. The project, which also follows the mixed-income format, will contain over 1,500 units along with commercial and community opportunities. The project has been lauded as one of the most significant public housing redevelopments in South Florida and the country, with HUD Secretary, Dr. Ben Carson, calling the project an example to follow around the nation.

Prior to his tenure at RUDG, Albert owned and operated real estate development, real estate brokerage and mortgage brokerage companies over the span of 20 years. After developing his first affordable housing development in 1999, he formed The Urban Development Group in 2002, focused on revitalizing communities by creating affordable homeownership for underserved markets. As a committed member of the local community, Albert has served on the Miami-Dade County Industrial Development Authority since 2005 until 2020 and is a former member of the Greater Miami Chamber of Commerce's Workforce Housing Committee. He also served on the board of the YMCA of South Florida from 2017 to 2019. In 2011, he was the President of the Builder's Association of South Florida where he was awarded the President's Award and was named Builder of the Year in 2009 and 2019.


