Chair Russo reminded the LEPC members of the points discussed during the last LEPC meetings, which included introducing LEPC presence at events such as the Governor's Hurricane Conference, FIU Disaster Expo event and assisting in hospital trainings related to batteries.



**7. Presentation by Joseph Trouba (Gopher Resource) on Lithium-Ion Battery Management Challenges: A Recycling Company's Perspective.**

Joseph Trouba, Gopher Resource Program Manager, presented on the topic of battery recycling, which encompassed details about management, challenges, and the strategies that Gopher Resource uses through their company.

**8. Chair's Report (Chair Russo)**

Training Task Force: Chief Pat Feagle from Ocala, Florida is the new Chair of the Training Task Force. The Training Task Force will be evaluating their current project boxes and re-prioritizing them based on the current needs of the teams. The main focus has been identified as emergency response training. The Florida HazMat teams will be comprehensively assessed on their training, inventory, and staffing, among other areas, and report back to the Response Commissions to keep track of team capabilities in disaster scenarios. The Offshore Hazmat Program is a cooperation between NOVA and the Coast Guard with the focus of training local and regional HazMat teams to assist in response and mitigation-related activities in the event of large-scale disasters off the Florida coast. The program will be based out of RESOLVE in the Port Everglades, and operational courses are scheduled for April/May 2026. The HazMat Symposium was green lit to move forward, and the South Florida LEPC would be available to sponsor some additional students in addition to the HazMat teams.

**9. Planning & Training Working Group Report (LEPC Vice Chair, Chief Brian Brown)**

Planning: The Hazardous Materials Emergency Response Plan (HMERP) was accepted into the FEMA National Exercise Program, with the aim of testing the LEPC Emergency Response Plan. However, funding for the exercise was placed on hold. The midterm planning meeting was held prior to the funding being held, in which the plan was set up and the scenario for testing was decided.

Training: The PEAC WMD software training continues to be available for the regional HazMat teams. Beginning November 12 through November 14, there will be a Propane Response 101 course being held in Hollywood, Florida.

Exercise: Vice Chair Brown provided the LEPC members with an opportunity to brainstorm through possible exercises or activities that can be further explored for the year 2026.

**10. SoFlaLEPC Coordinator Report (Hailey Lazzaroni)**

The South Florida LEPC completed its annual EPCRA How-to-Comply virtual workshop on October 29th via Zoom. An overview of the Emergency Planning and Community Right-to-Know Act (EPCRA) and the LEPC was provided by Hollywood Fire Rescue Fire Prevention Officer III, Meghan Grimsley, and an E-Plan training was provided by FDEM Tier II Unit Lead, Wendy Reynolds, to help facilities in the region prepare for the upcoming reporting season (January 1-March 1).



## **11. Member Comments**

Peter Schecter (Interested Citizen) shared that for all those members who are required to follow standards for training and certification, that National Fire Protection Association (NFPA) 472 is now consolidated with other standards into NFPA 470: Hazardous Materials/Weapons of Mass Destruction Standards for Responders. Mr. Schecter also shared that the next meeting for that standard committee will be held in December 2025.

Aimee Hernandez (Broward EM) referenced some exercises that Dan Scarborough had mentioned in a previous meeting, the BioWatch and ChemPrep exercises. The government shutdown interfered with the completion of both exercises and the next scheduled dates continue to be undetermined until the shutdown is lifted. In addition, Ms. Hernandez shared that the Broward County Emergency Management is in the process of updating its Ingestion Plan. In 2026, there will be a series of workshops with various stakeholders to discuss the Plan itself, the gaps and information in advance of the 2027 FEMA-required Ingestion exercise.

Laura Wyness (Coast Guard) shared that there will be a full-scale oil spill response exercise scheduled for April 28th and 29th in Port Everglades to test the new Area Contingency Plan, which is a multi-hazard plan focusing on HazMat and oil spills in waterways.

## **12. Public Comments**

Russell Accardi, Vice President at L2 Defense, offered the group information about an 8-hour program that was held for the HazMat teams in February 2025. Stakeholders involved in the program were able to network with other organizations and share insight their respective roles in the kind of incident performed.
